Old Business

- College Goal Sunday
 - CAPFAA agreed to be the fiduciary for CGS funds
 - There is no longer a national College Goal Sunday organization
 - The effort is now lead by NCAN known as "Form Your Future"
 - Seeking to formalize the relationship between CAPFAA and College Goal Sunday

- Motion from Alex (from October 2017 meeting) back on the table-to have either the president of CAPFAA or someone the president designated be a member of the College Goal Sunday CT steering committee
 - Discussion-
 - Would CAPFAA continue to have someone on the committee if there is no longer a fiduciary relationship?
 - What if the committee disbands?
 - CAPFAA would need some guidelines and standards of what our formalized role would be within the steering committee
 - Amended motion-At the discretion of the sitting president, the president of CAPFAA or someone the president designates be a member of the College Goal Sunday CT steering committee so long as this committee exists
 - Vote
 - 6 in favor
 - Motion passes
- o Josh to follow up with CHELSA for additional funds for additional CGS sites
 - There were 10 sites- increased to 12 sites
 - \$250 per site
- Scholarship recipients
 - From last year were contacted and enrollment verified
 - Recipients for this year contact in January
- Alex motioned to waive the event attendance fee for the chair of the event
 - Second-Steve
 - Discussion-
 - Approved for CAPFAA Conference chair and co-chair at previous meeting
 - Waive attendance fee for Chair only, not co-chair as well
 - Wait to extend this idea to other events besides CAPFAA Conference
 - Waiving the attendance fee may cause Code of Conduct issues at some institutions
 - Amended motion- to waive the event attendance fee for the vice-president of CAPFAA for events directly sponsored by the training committee that is chaired by this individual
 - Multi-day events or Multiple events throughout the year
 - Vote
 - o 4 in favor
 - 2 abstained
 - Motion does not pass
